

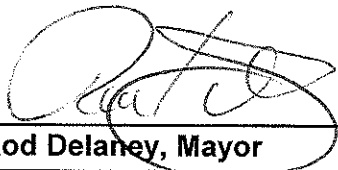
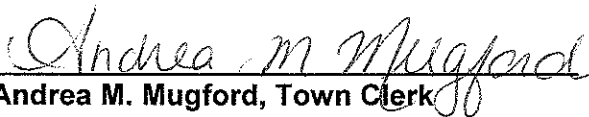
**MINUTES
