

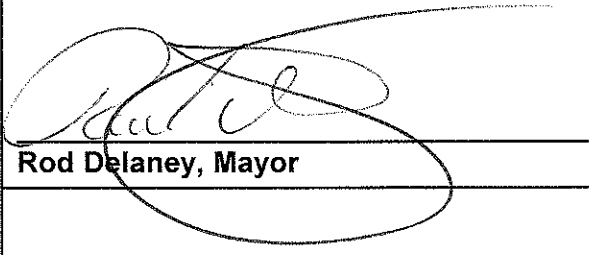
**MINUTES
